Introduction

The Equilar Data Feed enables users to build applications incorporating an extensive dataset of corporate executives and board members. Familiarity with Equilar's ExecAtlas service is helpful as the data feed provides a subset of the information provided through that platform. This document also assumes familiarity with the programming language you will be using to obtain and parse the data.

This document defines the Equilar Data Feed for receiving information on individuals, organizations, and related details. The dataset includes executives and board members at public, private, and non-profit organizations. Coverage is global with a concentration on the United States.

Receiving the Data Feed

All data feeds will be in CSV (comma separated variable) format and delivered via SFTP, Google Cloud Storage or Snowflake.

All updates will contain the complete data set as per the agreement. Changes to "Person" and "Organization" data can be determined using the field "update_date". Any related data corresponding to these persons or organizations may have changed when "update_date" is modified.

Packages



The Equilar People Business Intelligence Data Feed is split into three packages and contains 12 files by default (People Business Intelligence). The remaining files are accessible through two supplemental add-ons (Equity & Compensation; Executive & Director Relationships). The table below details which files are included in each package.

The schema is centered around the person and organization tables. Almost every other table will have one or more columns containing a person_id or organization_id.

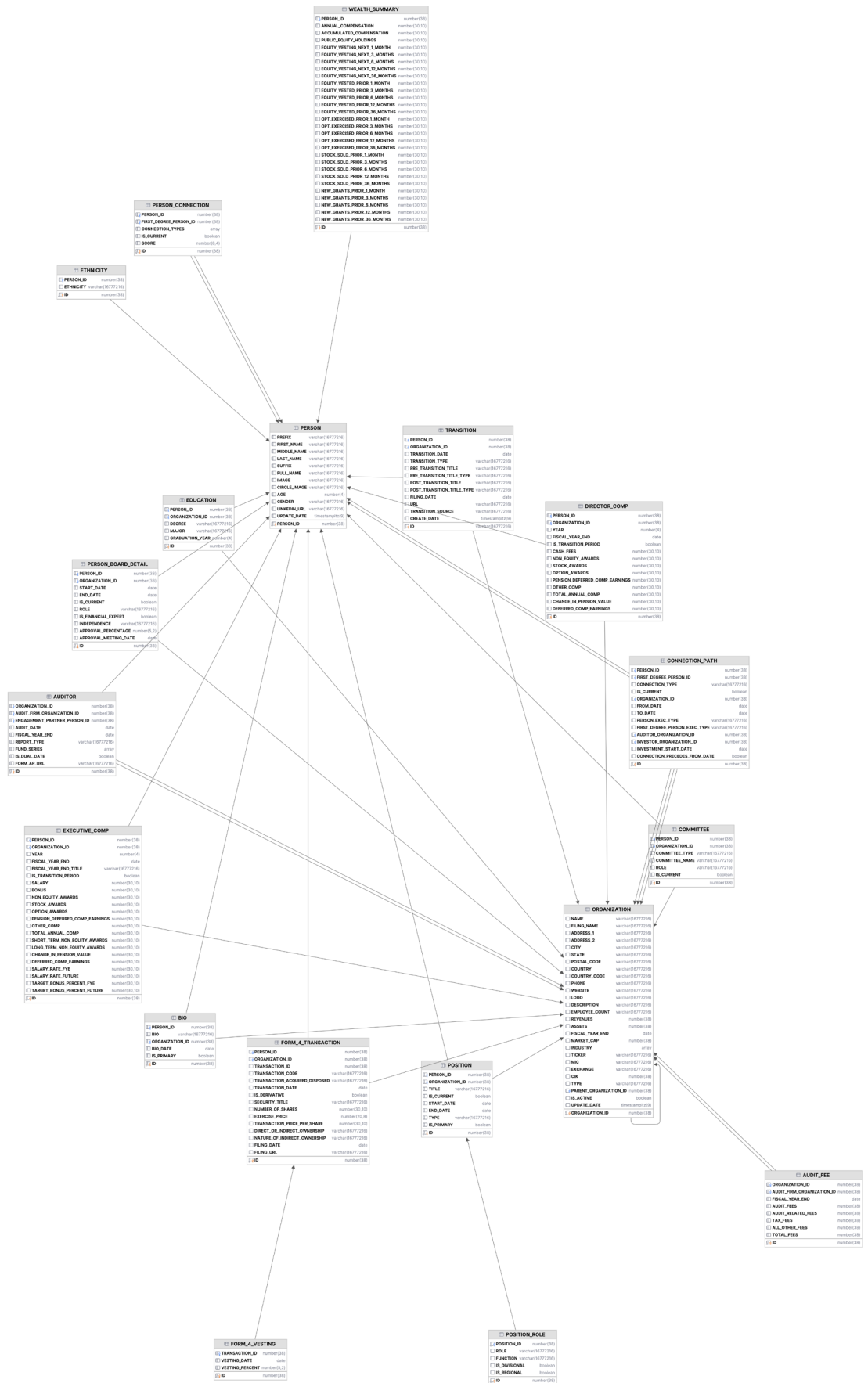
